Old Business:

- We need to confirm tryout dates and get information on the web, both BSC and the state. Steve will be the contact for this; he will make sure they are handled properly.
- Email Doug about scholarship winner and get awarded.
- Contact Rick about Berry Farm agreement.
- Contact Pete about a sign sponsorship for Micki at Soccer Zone
- Kevin will start fundraising collection on May 17
- Need to revisit fees for trainers, Steve, and Dennis. Appoint committee to evaluate Steve and Dennis's job and conduct meeting with them.

New Business:

- Micki from Soccer Zone gave presentation about offering spirit wear for BSC. BSC would get portion of money back. Board approved to have Micki begin process of building site for us.
- Complete inventory of uniforms, prepare fall order (sizes and color). Complete equipment order of balls, nets and flags.
- Bob will draw up a proposal to present to board to get funds to pay for training to complete his coursework. Fees are for hotel, class, and transportation.
- Dennis asked if older teams could do the recreational training instead of the select coaches. MaryAnn asked Steve to organize the training and setting a summer training agreement for field usage, fees, and limitations.
- Motion was passed to raise registration fees for u15-u19 ENSA players to 90.00
- Work on revising the coaches meeting in June.

The following reports were given verbally:

Treasurers: (given by Bill Brickman for Marv)

- Currently have \$35,000 in account with \$5800.00 out in checks. Fundraising deposited \$900.00.

Age Group Directors:

- U8 boys: Had a problem with the coach vs. parents. The coach had to leave the Leopards. Doug is now covering this vacancy. Doug would like to find good, quality coaches for u9/u10 for developmental purposes (NSL/ENSA)
- U8 girls: Bluejay team (Todd Smith coach) referee/coach issue, letter from opposing coach about incident.
- U10 girls: Chris reported that he is not getting a response from coaches but knows that they are playing.

Referee Director:

- Jeff asked about a policy process to get things posted to the web.

Registrar:

- Reported 29 Select teams, only 10 have signed up for fall season

Field Maintenance:

- Field mowing will occur each week now. Watering will be done as needed; sprinkler system is now off.
- We need two new goals before the fall season.
- Field 7 and possible Field 13 need to come down for the fall season to recover. Field 11 can be repaired and reopened. Draining and low spots need to be fixed on Field 10 before it can be used. We will need to fill in low spots on Field 8.
