**SELECTION:** The participants will be selected by USA Hockey District Referee-in-Chief. Participants will be selected on the basis of their hockey officiating experience, supervisory experience, personal character, thoroughness of application, conduct and ambitions.

**FACILITIES:** United States Olympic Training Center (USOC). Official Olympic Training site. Facilities will include: housing, dining hall (breakfast, lunch, dinner), weight room, physiological testing lab, recreational facilities.

**TRANSPORT.:** Must provide own transportation to and from Olympic Training Center.

**INSURANCE:** Paid for by the USOC/USA Hockey.

## **EASTERN SEMINAR INSTRUCTOR STAFF TRAINING SESSION**

### **OBJECTIVES**

To instruct USA Hockey Seminar Instructors on the proper mechanics of teaching officiating seminars. To develop uniform teaching criteria, strategies and curriculum. To enhance the involvement of the more experienced officials as teachers. To broaden the base of interested instructors throughout the country.

### **CRITERIA FOR ATTENDANCE**

All participants must:

- \* Be designated as a potential Seminar Staff Instructor by the District Referee-in-Chief
- \* Participate in conducting USA Hockey Officials Seminars in their district following the Training Session.

All participants should:

- \* Be respected officials/administrators in their district.
- \* Be actively involved in the district program.
- \* Have the desire to assist in the training and development of other officials.

### **APPLICATION**

- \* Attendance at Seminar Instructor Staff Training Sessions will be by invitation only.
- \* Applications will be distributed and submitted by District Referees-in-Chief ONLY!

### **MARCH 8, 2010 DEADLINE FOR APPLICATIONS TO DISTRICT REFEREE-IN-CHIEF.**

Late applications can not be accepted.

### **SELECTION PROCESS**

The number of invitations per district will be based upon the number of registered officials from each district. The Officiating Program Staff will select participants based on the thoroughness of the application and recommendations from the District Referee-in-Chief and Local Supervisor(s) of Officials. Officials will be notified of their selection upon receipt of the application in the National Office. **Submission of an application is a commitment to attend, if selected, and failure to show up without a valid reason may result in possible disciplinary action**

### **COSTS**

All transportation to and from the site is to be supplied and paid for by the participants, unless appropriate funds have been budgeted by the district to reimburse a portion of the expenses. The United States Olympic Committee and USA Hockey will supply and pay for room, board and instructors fees. There is no fee for participation.

### **INSTRUCTORS**

Instructors will be selected from the top instructors involved with the USA Hockey Officiating Education Program. They shall include District Referees-in-Chief, Local Supervisors of Officials, Local Seminar Instructors and other Officiating Program personnel.
