**Terms and Conditions**

I, the legal guardian of the above named player ("Candidate") for a position on a Little League Team, hereby give my approval to participate in any and all Little League Activities with Allied Gardens Little League, Little League Incorporated, and it's affiliates ("AGLL"), including, but not limited to transportation to and/or from activities and to be bound by all terms and conditions contained herein:

1. I understand that participation in Little League sports may result in serious injury and protective equipment cannot prevent all injuries, and do hereby waive, release, absolve, indemnify, and agree to hold harmless from any claim AGLL and it's Organizers, Sponsors, Supervisors, Participants, League Officials, and any person transporting Candidate, arising out of any injury to the Candidate whether the result of negligence or for any other cause.
2. I agree to return upon request any equipment issued to the Candidate in as good conditions as when received except for normal wear and tear.
3. I agree that the Candidate may be required to try out for a team. If such does not attend at least 50% of scheduled tryouts, the local Board of Directors' approval is required for the Candidate to be placed on a team.
4. I understand that the Candidate may be chosen at any time to play on a Major Division team, if he or she is of the correct age for such division as determined by the local league and Little League Baseball. Declining to move up to such Major Division team will result in forfeiture of eligibility for the Major Division for the current season, and may be subject to further restrictions by the local league.

5. I agree to provide proof of legal residence and age; acceptable forms of proof are determined by the Local League and/or Little League Incorporated. I understand that the Candidate must be eligible under the residence and age regulations of Little League Baseball, Incorporated, to participate in this Local League, and that if any controversy arises regarding residence and/or age, the decision of the Charter Committee in Williamsport shall be final and binding. I further understand that if any participant on a Little League team does not qualify for participation in the local league based on residency and/or age, such participant and/or team on which he/she participates may be found ineligible, and forfeit(s) and/or suspension of Tournament privileges may be decreed by action of the Charter Committee or Tournament Committee.
6. I hereby give consent to use my player's image or likeness, to include but not limited to drawings, photographs, video, in digital or printed form for the purpose of advertising, promotion, sponsorship or for any activity sanctioned by AGLL. I understand that I will not receive remuneration or any other consideration for AGLL's use of said images. I agree to indemnify and hold harmless AGLL, including current and past League Officers, Volunteers, Agents or Contractors for any such use by AGLL or any other party. You may request in writing that AGLL discontinue the use of a specific photo(s), but you may not request that all photos including a specific player(s) not be used. Any request to discontinue use of photo(s) may be honored at the sole discretion of AGLL's Board of Directors.
