Notice of Compulsory Attendance Law

This notice is to advise you that according to Section 25.085 of the Texas Education Code, children between the ages of six (6) and their 18th birthday are required to attend school on a daily basis unless specifically exempted by Section 25.086. A child who is required to attend school under this section shall attend school each day for the entire period the program of instruction is provided. The law places the responsibility on parents or those who stand in parental relationship to see that children attend school regularly. Any parent or person failing to require his child to attend school as required by law may be subject to a fine – an offense under this section is a Class C Misdemeanor and is punishable by a fine of UP TO \$500 for each offense. Section 25.095 states that a parent will be notified in writing if a child is absent 10 days or parts of days during a six-month period or three (3) or more days or parts of days during a four-week period. iSchool High will enforce these laws as stated by the Education Code and will report all offenses to the local authorities. By signing below I am acknowledging the receipt of this notification.

A person who knowingly falsifies information on a form required for a student's enrollment in iSchool High shall be liable to iSchool High if the student is not eligible for enrollment, and is enrolled on the basis of false information. For the period in which the student is enrolled, the person is liable for the maximum tuition fee the District may charge or the amount the District has budgeted per student as maintenance and operating expense, whichever is greater.
