The Dallas Stars Elite Hockey Club (DSEHC) is pleased to announce the inaugural Summer Cup of hockey Tournament. The tournament will feature only the top teams in North Texas in mixed age categories consisting of 3 brackets: **Pee wee Minor (\$800), Pee wee Major (\$850), and Midget Minor (\$900)**. The tournament will consist of 4 teams in each bracket with each team receiving a 4 game guarantee. The tournament will take place 13-15 Aug. The site for the event will be Dr Pepper StarCenter – Valley Ranch located at 211 Cowboys Parkway in Irving, TX

Each team will play a round robin of 3 games. After the 3 game preliminary round robin, each team will play a final 4th game as follows: 1vs2, 3vs4.

Each team will play one game on Friday, 2 games on Saturday and the final 4th game on Sunday (exception will be the Midget Minor bracket who will play 1-1-2 game schedule)

The goal for the tournament is Most Games (each team plays 4), Most Minutes (15 min stop time), Lowest Cost, Top Competition - North Texas Teams AAA/AA invite only

- All tournament games will be governed by USAH rules.
- All players must obtain a valid USA hockey registration confirmation number with USA hockey which is required for 2010-11 season league play. The 2009-10 USA hockey registration is only **Valid from May 1, 2009 - April 30, 2010**.
- All teams play 4 games guarantee
- All games will be 15 minute stop time periods
