

AGREEMENT WITH JACKSON YOUTH SKATING, INC. (JYS)
d.b.a. Jackson Youth Hockey (JYH)

The undersigned would like one or more members of their family, including, but not limited to, those individuals specified on the JYH Program Registration form, to participate in recreational ice skating activities organized by Jackson Youth Skating (JYH), a Wyoming nonprofit charitable organization, and / or directors, officers, coaches, employees, and / or others formally or informally affiliated with or helping JYH.

These recreational activities involve substantial risks of injury to the individuals engaging in these activities. These recreational activities will only be furnished to the undersigned and the family members associated with the undersigned on the terms set forth herein, whereby the undersigned and their family members must bear the risks and costs of any such injuries. These are voluntary recreational activities and will only be conducted under these terms. If the undersigned want financial protection against personal injuries, then the undersigned must obtain their own liability and health insurance to protect themselves and their family members and guests.

Therefore, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the undersigned hereby waive, and indemnify and agree to hold harmless JYH and its directors, officers, coaches, employees, and / or others formally or informally affiliated with or helping JYH from and against, any and all claims or liabilities against any of them, and related expenses (including reasonable attorneys fees), relating to or arising out of the participation in these recreational activities by any of the undersigned and their family members, in the absence of willful misconduct on the part of the applicable indemnified party.

In those cases where the undersigned volunteers to assist JYH in any capacity, including coaching, assisting the coaches, administration or any other activity, the undersigned hereby acknowledges and agrees that he or she is an "at will employee" of JYH and thereby is subject to dismissal at any time for any cause. JYH requires all volunteers to read and adhere to the statements of Goals and Values and the Codes of Conduct described in the current JYS/JYH Operating Plan and Organization. The undersigned acknowledges that he or she has read these statements and is committed to support them.

This Agreement shall remain in full force and effect so long as any of the undersigned and their family participates in these recreational activities, and the waiver and indemnities set forth herein shall remain in full force and effect as to any later claims and / or liabilities relating to any such activities. This Agreement may not be unilaterally cancelled or modified by the undersigned. Any cancellation or modification must be in writing and signed by the undersigned and their family members and their successor, heirs, estates and personal representatives.

The undersigned as a parent gives permission for the emergency medical treatment of their child(ren) if an accident occurs.

This is a valid and binding Agreement which has been properly entered into by the undersigned, acting both individually and as a guardian of minor family members.
