

# RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

DESCRIPTION AND LOCATION OF SCHEDULED EVENT(S)

In consideration of being permitted by NORCO Juniors to compete, officiate, observe, work for, or participate in any way in the EVENT(S), THE UNDERSIGNED acknowledges, appreciates and agrees that:

1. The risk of injury from the activities involved in these EVENT(S) is significant, including the potential for permanent disability and death.
2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern, I will remove myself from participation and bring such attention to the nearest NORCO representative immediately.
3. **I hereby release, waive, discharge, and covenants not to sue** the other participants, sponsors, advertisers, promoters, officials, NORCO personnel, owners, and if applicable, lessees, of premises ("RELEASEES") used to conduct the EVENT(s), **from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all injury, disability, death, or loss or damage to person or property from involvement or participation in these EVENT(S), whether arising from the negligence of the RELEASEES or otherwise**, to the fullest extent permitted by law.
4. **I hereby indemnify and hold harmless** the RELEASEES and each of them **from any loss, liability, damage, or cost** they may incur arising out of or related to the EVENT(S), **even if arising from their negligence**, to the fullest extent permitted by law.
5. **I hereby acknowledge that the activities of the events can be very dangerous** and involve the risk of serious injury and/or death and/or property damage. I knowingly and freely assume for myself all such risks, both known and unknown, **even if arising from the negligence of the RELEASEES or others**, and assume full responsibility for my participation.
6. Image Release: In consideration of the participant being allowed to participate in any way in these EVENT(S), the undersigned agrees that such participants likeness may be photographed or videotaped and that such image or statements may be published.
