

## **GTHA House Committee Meeting Minutes September 6, 2010**

Meeting was called to order by Dianne Jurica at 7:00 p.m.

### **BUDGET REPORT:**

**Cost Determination/Budget Report:** Deb Derrer had been invited to explain how the cost of each division is determined. She did provide a spreadsheet explaining the breakdown for each division. It was very informative and many questions were answered.

**Scheduling:** (per Deb Derrer also)

Checking Clinic: Need to find out when the clinic is and get it posted on the website. Dianne J will find out.

Practices will be held on the same day every week this year – for all Divisions. There will be additional practices periodically also – and most games will be played on weekends.

**Squirts (1-4)** 7:15/7:30 @ Centre Ice (there will be four House Squirt teams this year)

**PeeWee (1-3)** 7:30 @ Howe and 8:15 @ Centre Ice. Will also skate with Girls U/12's. Will rotate thru the Pee Wee teams to share the ice with girls.

**Bantam:** 8:30 @ Howe, 8:30 @ Centre Ice

October 6<sup>th</sup> start date for all. Deb is scheduling for entire year so any tournament weekends needed off (per coaches) must be in by Friday, September 10, so she can get schedule done. Some discussion was held about this as some in attendance felt that it is nicer if parents can help choose the tournaments they attend. She will keep major tournament weekends that teams typically have attended in the past open on the schedule.

### **DIVISION REP REPORTS:**

**Mites:** No report (Rep not at meeting)

**Squirt:** Sheryl reported that there will be four house teams this year.

**PeeWee:** Mike reported that there will be three house teams this year. We only have two goalies however. It was discussed that a goalie is really needed at this level and so after some discussion about it, a suggestion that a particular 2<sup>nd</sup> year Squirt be asked to move up

who has interest in the goalie position. Mike will ask if player/parents are interested and let us know. We all felt this to be a good solution.

**Bantam:** Rich reported that there will be three or four house teams this year. The dilemma is that there are only three goalies. At the Bantam level- you really need a designated goalie on the team. It was discussed in length and it was suggested that Rich ask if anyone is interested in playing goalie – or splitting goalie duties, and a hockey coach (Fernandez) would work with the goalie. Rich will email Bantam families and get back to Dianne by Friday to make a decision as to how to proceed.

#### **DIRECTOR OF HOCKEY (OFFICE) NEWS:**

**HOUSE TOURNAMENTS:** Amy Drake and Todd Spaulding can't do it. It was first suggested that Julie R check the emails for the GTHA tournament and forward to appropriate person running the tournament (I.E. Division Reps) Division Reps voiced concern about not feel comfortable running the tournaments themselves. Dianne J said that she had wanted a House Tournament Director but Exec board did not feel one was necessary. Mike Pascarelli offered to be the House Tournament Director (he was last year also) and Dianne J will take it to Exec Board to seek approval.
