Following teams still have openings: U10 girls, one player; U14 girls, two players; U18 girls, one player; U9 boys, one player; U11 boys, three players. • Summer committee - Jim voiced concerns about one of the club coaches' demands on the club. Dave to keep tabs on it during the summer. • Tournament – Committee meeting scheduled for 4-11, however notes from the last tournament meeting stated 4-17. Dave to verify and send out communication to the committee. • Field Committee – Tom will talk to Jim Taylor to arrange for taking down and storing of nets for the winter requests. • Uniforms - Can't get exact matching uniform shorts. We can get the matching color just slightly different style. Board members present were fine with this. • Treasurer Report - Still working on funds outstanding from the sportability issue. • District Update - Be extra diligent to inspect goals to ensure they are anchored. At the last MYSA meeting they stated 4 fatalities and many injuries last season across the country due to goal falling on players. Changes to the teams in MYSA; Somerset added to MYSA and 4 Somali teams from Minneapolis. NESAA will not be moved to north district. • Training Update - Small skills finished. Dave to schedule this same activity for next year. Large skills one session left; April 10th at Bielenberg. Added in-season goalkeeper training to the pre-season goalkeeper training. Each session 1 hour; dates will be posted on the website. • Equipment Update - Coaches picking up bags, we are in good shape. Low budget year as compared to last year regarding equipment. • New website/registration software. Dave presented information on various website companies.
