Gameplay Policies:

- 1.) Infinity Lacrosse LLC enforces all rules as deemed by the US Lacrosse rulebook for the appropriate age level of the event.
 - 1a.) Failure to comply with these rules will result in a one time warning. This warning is subject to the entire duration of the specific event, and not just the day the warning was issued.
 - 1b.) Failure to comply a second time will result in immediate ejection from the event without refund. Infinity Lacrosse LLC reserves the right to eject players for either the remainder of the day the warning was specified, or the remaining duration of the event without refund.
 - 1c.) Infinity Lacrosse LLC reserves the right to eject any player without a prior warning if deemed necessary for the safety of the other participants.
- 2.) Infinity Lacrosse LLC reserves the right to warn or object any player who appears to “horsing around” and or distracting the coaches attention from observing play, and or distracting other players and thus hindering the learning environment.
- 3.) Proper equipment must be worn at all times. **Equipment - RULE 1 SECTIONS 6 & 9.** Equipment will conform to NFHSA crosse dimensions and equipment requirements, including NOCSAE — approved helmets, with the following modifications:
 - 3a.) The length of the short crosse may be 37 to 40 inches for offensive players in the Lightning and Bantam Divisions and defensive players in such divisions may use a stick with a length of 37 to 72 inches.
 - 3b.) Rib pads are strongly recommended.
 - 3c.) Infinity Lacrosse L.L.C has a limited amount of equipment to loan to players. Infinity Lacrosse L.L.C is not liable for any defaults in aforementioned equipment.
 - 3d.) Players refusing to wear proper equipment will not be allowed to participate in any drills.
