Registration Agreement

Attention Parent/Legal Guardian: Read the following carefully. By signing this form you are giving up certain legal rights.

Agreement:

In consideration of my child, _____, participating in Elite Champion Gymnastics classes, events, competitions, and activities, I agree to be bound by each of the following:

1. **Eligibility:** I agree to comply with the rules of Elite Champion Gymnastics.
2. **Consent to Treat:** I hereby give my consent to Elite Champion Gymnastics and/or any host organization to provide, through a medical staff of its choice, customary medical/athletic training attention, transportation, and emergency medical services as warranted in the course of my child's participation.
3. **Photographic Release:** I give Elite Champion Gymnastics permission to photograph my child for marketing purposes. I understand that Elite Champion Gymnastics will not identify names with images unless permitted.
4. **Waiver and Release:** I am fully aware of and appreciate the risks, including the risk of catastrophic injury, paralysis, and even death, as well as other damages and losses associated with participation in gymnastic activities and events. I understand that the mats, pits, spotting rigs, and other safety equipment and apparatus provided for my child's protection, including the active participation of a coach or teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent serious injury. The risk of harm may be limited by all of the safety equipment and trained coaches, but never eliminated.

In consideration for allowing my child to use these facilities, I on my behalf and the behalf of my child, **hereby release and covenant not-to-sue** Elite Champion Gymnastics, its owners, administrators, directors, agents, officers, volunteers, employees, other participants, sponsors, and advertisers, **from any and all present and future claims resulting from ordinary negligence on the part of Elite Champion Gymnastics or other listed** for property damage, personal injury, or wrongful death, arising as a result of my child engaging in or receiving instruction in gymnastics, dance, tumbling, cheerleading, or any other activities incidental thereto, wherever, whenever, or however the same may occur. Further, I agree to indemnify, save, and hold harmless Elite Champion Gymnastics and all others listed for any and all claims arising as a result of my child engaging in or receiving instruction in Elite Champion Gymnastics activities incidental thereto, whenever, wherever, or however the same may occur.

I understand that this waiver is intended to be as broad and as inclusive as permitted by the laws of the state of Texas and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be within the state of Texas.

5. **Acceptance:** By signing this form, I affirm that I am of legal age and am freely accepting this agreement. **I have read this form and fully understand that by signing this form, I am giving up legal rights** and or remedies, which may be available to me or my child for the ordinary negligence of Elite Champion Gymnastics, or any others listed above.
