

## **Membership Agreement (Parent or Legal Guardian)**

The undersigned, acknowledging that s/he is the parent or legal guardian of the player member of the Grosse Pointe Hockey Association (GPHA) identified below, hereby agrees and consents to the following terms and conditions of the GPHA membership:

- Each player must be duly rostered on a GPHA team and shall play as a member of such team in the GPHA.
- Player members are expected to participate in all regularly scheduled team games, practices, and functions.
- All members shall abide by the GPHA constitution, By-Laws, Rules and Regulations, applicable Rules and Regulations of MAHA and/or USA Hockey, and all rules duly adopted by the team on which the player participates.
- I understand and agree that, as the parent or legal guardian of the player named herein, I am financially responsible to the team on which the player is rostered for the pro-rated share, based on the total number of players rostered on the team, for all dues, fees, expenses, charges or other costs imposed by GPHA or the team in connection with the player's association with such team and GPHA during the 2009-2010 season (the "Fees").
- The Undersigned acknowledge and agree that they will be invoiced approximately monthly by the team manager for the prorated Fees. The undersigned further acknowledges that they shall pay such invoice with fifteen days of receipt. Any failure to pay timely will be immediately reported to the GPHA Treasurer.
- In the event that a parent or legal guardian is unable to pay any dues, fees or other costs imposed by GPHA or the players' team, the undersigned parent or legal guardian may request a meeting with the Treasurer of GPHA and seek a payment plan option, which may be granted or denied within the sole and absolute discretion of the GPHA Executive Board. Notwithstanding the approval of any such payment plan, the undersigned remain responsible for the Fees.
- The undersigned agree that if the player named herein withdraws or drops out of the GPHA program for any reason whatsoever, including, but not limited to disinterest, injury, move, or suspension, neither the player nor the undersigned are entitled to any refund, partial or otherwise, of Fees, and shall remain responsible to GPHA and the team for the entire season's Fees, unless released by the GPHA Executive Board in a written document signed by the President and the Treasurer of GPHA.
- The undersigned acknowledge and agree that failure to pay all required Fees as they become due may, in the sole discretion of the President and the Treasurer of GPHA, result in suspension of the player's membership with GPHA and playing privileges with the GPHA team. Continued failure thereafter to pay will result in automatic loss of membership standing and ineligibility to participate in GPHA programs and activities, for the 2009-2010 season and any subsequent season until such Fees are paid in full.
- The Undersigned acknowledges and agrees that they are liable for all costs incurred by GPHA in collecting same, including but not limited to court costs and reasonable attorney's fees.
