Waiver and release of liability: PLEASE READ CAREFULLY. THIS IS A LEGALLY BINDING DOCUMENT THAT WAIVES AND RELEASES LEGAL RIGHTS AND LIABILITIES.

In consideration of being allowed to participate in Skate to Excellence programs and its related events and activities, including Ice Hockey, the undersigned acknowledges, understands, and agrees as follows:

1. The risk of injury from the activities involved with or related to Skate to Excellence programs and events is significant, including the potential for property damage, personal injury, paralysis, and/or death. Although particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury or damage does exist.
2. **I knowingly and freely assume all such risks noted above**, both known and unknown, and assume full responsibility for my participation in or presence at Skate to Excellence programs or events.
3. I willingly agree to comply with the customary terms and conditions in place for participation in or presence at a Skate to Excellence program or event. If, however, I observe any dangerous or potentially dangerous situation during my presence and/or participation, I will remove myself from participation and immediately give notice of the situation to a Skate to Excellence official or other responsible person.
4. I, for myself and on behalf of all of my heirs, successors and assigns, **DO HEREBY WAIVE, RELEASE, AND HOLD HARMLESS SKATE TO EXCELLENCE, AND ITS OWNERS, EMPLOYEES, COACHES, MANAGERS, AND OTHER REPRESENTATIVES, AND OTHER PARTICIPANTS, SPONSORING AGENCIES, ADVERTISERS, AND OWNERS, LESSORS, AND LESSEES OF THE PREMISES AT WHICH AN ACTIVITY OR EVENT IS BEING CONDUCTED (ALL COLLECTIVELY HEREINAFTER REFERRED TO AS "RELEASED PARTIES")**, from all liabilities, causes of action, costs and/or expenses (hereinafter collectively referred to as "Claims"), arising out of or related to participation in or association with Skate to Excellence programs or events, including Claims involving injury, death, and/or damage arising out of or related to the negligence of any one or more of the Released Parties, or any other party.

I have read this Waiver and Release of Liability document and I fully understand its terms. I understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any assurance or guarantee being made to me.
