Terms and Conditions

AGREEMENT:

Refund Policy: Registration fees are non-refundable at any time.

Payment Agreement: The registration fee for hockey program, as determined by the Board of the OHC, covers ice rental, league fees, and other expenses incurred to allow participation in the OHC and makes the participant eligible to join a team representing the OHC. In addition to the Standard Fee, each player will be required to register online with USA Hockey, at the player's expense, in order to be an insured member of USA Hockey for the upcoming season. I consent to my child's participation in the OHC program and agree to pay in accordance with the fee structure outlined above, along with any mandatory fundraising fee. I understand that no player will be allowed on the ice or to participate in games, unless the registration fee has been paid in accordance with the payment scheduled outlined above, all required forms have been signed by a parent or legal guardian, and any outstanding fees from previous years are paid in full. I understand the OHC reserves the right to delete a player from the team roster for non-payment of fees, thereby making that player ineligible for practices, games, or scrimmages. I further acknowledge the refund policy of the OHC, have read same, and agree to this policy in the event that it is decided that my child leaves the club. I hereby give permission for my child's statistics and/or accomplishments, which may or may not be accompanied by the child's name, address, and /or photograph, to be electronically displayed on the OHC web page or given to the media for electronic or print publications, and hereby release the OHC from any liability resulting from or connected with the publication of such work. In consideration of my child playing hockey for and in the OHC, the undersigned hereby releases the City of Omaha, Sidner Ice Rink, Mid-America Center, OHC, its Directors, Officers, Board Members, Officials, Coaches, and their agents from any claim for injury, loss, damage, death, or expense sustained by the person or property of the player, arising during any game, exhibition, scrimmage, or practice activity with full knowledge of the inherent risks thereto and assumes all risks accordingly. I have read, understand, and agree to all of the conditions stated above.

Code of Conduct: I will refrain from negative cheering and will encourage fair play and good sportsmanship at all times. I will provide a safe and fun environment for play and will refrain from any action which may cause injury to players, coaches, other parents, or officials. I will be responsible for my own safety and remain alert to help prevent accidents. I will support the referees and coaches by trusting their judgment and integrity. I will avoid direct confrontations with other parents, players, or coaches. I will refrain from excessive celebration intended to taunt the other team and avoid excessive demonstrations of frustration or anger. I will refrain from approaching the bench in a game situation unless summoned by a player or coach.

Photographic Release of Liability: I ACKNOWLEDGE AND CONSENT to the publication and/or display of any photograph(s) taken of me and / or my child for OHC publications, brochures, websites, flyers, or articles for outside publication. I understand that by my consent, any photograph(s) in which I or my child appears may be displayed on the OHC or in OHC publications. Also by being so transmitted, they may be susceptible to being copied, otherwise used, and perhaps altered. I ACKNOWLEDGE that OHC is not liable to me or my heirs for any misuse or alteration of my or my child's photograph(s) by others.
