



# 2011 SUMMER SKILLS CAMPS BREWER

## Skills and Drills Camp 2011

### Week 1

JULY 6-7-8-9:00-3:00 pm

Skating development – focus on skills required to build a strong foundation such as edges, balance.

Puck Skills – stickhandling, passing, and shooting all performed at speed.

Competitive scenarios – used to reinforce tactics and concepts in a competitive environment

Game play – read and react skills, general team play principle

### Week 2

July 20-21-22 9:00-3:00 pm

The camps 2<sup>nd</sup> week will consist of on-ice work immersing the players into puck handling and Skating drills in game situation scenarios. Some of the topics will include scoring (how to improve your odds, shooting habits, eye of the puck, dekes/fakes, etc), puck protection (1v1 in all areas of the ice including corners, net drives, etc), puck support (cycling, picks, activity away from the puck, touch/area passing, etc), and competition scenarios (puck battle scenarios, small area games, etc.).

This will be a great chance for the player to get a feel for the puck and get their legs going underneath them, essentially "syncing" the components of strong play with the puck

Each camp will offer 3 age groups with 1.5 hour sessions per group per day. Each group will be limited to 18 players.
