### **Waiver of Liability**

For and in consideration of the participant's registration with the Westfort Hockey Association Power Skating Camp, any of its affiliates, local association and member team (Westfort Hockey Association Power Skating Camp), and being allowed to participate in all events and member camp activities, the parent(s) or guardian(s) of the participant, relinquish any and all liability for and cause of action for personal injury, property damage or wrongful death occurring to the participant arising out of participation in any events or camp activities or the sport of ice hockey, or any activities incidental thereto, wherever or however they occur, and for such period said activities may continue, and by this agreement, and such claims, rights, and causes of action that the participant may have, are hereby relinquished and the participant or parent(s)/guardian(s) does(do) so on behalf of themselves and their and the participant's heirs, executors, administrators and assigns.

The participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume all risks inherent in ice hockey and any member team activities, and understand that the said sport and activities involve risks to the participant's person, including bodily injury, partial or total disability, paralysis, and death, and damages which may arise wherefrom and that they have full knowledge of the said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of others, including the "releasees" identified below. It is further acknowledged that there may be risks and dangers not known to use, or are not reasonably foreseeable at this time.

The participant and/or participant's parent(s)/guardian(s) acknowledge, understand and assume the risks, if any, arising from the conditions and use of ice hockey rinks and related premises and acknowledge and understand that included within the scope of this waiver and release is any cause of action arising from the performance, or failure to perform maintenance, inspection, supervision or control of said arenas and for the failure to warn of dangerous conditions at said rinks, for negligent selection of certain releasees, or negligent supervision or instruction by the releasees.

It is the purpose of this agreement, to exempt, waive and relieve the releasees from any liability for any type of personal injuries, property damages, and wrongful death caused by negligence, including the negligence, if any, of the releasees.

"Releasees" include Westfort Hockey Association, Hockey Canada, its affiliate Associations, local Associations (Hockey Northwestern Ontario), member teams, event hosts, other participants, all coaches, team managers, team trainers, team players, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of them, their officers, directors, agents and employees.

The participant or the participant's parent(s)/guardian(s) agree that if any claim for the participant's personal injury, slander and any type of negligence, criminal acts or wrongful deaths or suicide is commenced against the releasees, he/she shall defend, indemnify and save harmless the releasees from any and all claims or causes of action by whomever or wherever made or presented for the participant's

personal injuries, property damage, slander, and any type of negligence, criminal acts or wrongful death/suicide.

The participant and/or the participant's parent(s)/guardian(s) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of the releasees, that they are fully advised of the potential dangers of ice hockey and ice skating, and understands that these waivers and releases are necessary to allow amateur ice hockey and skating instruction to exist in its present form.
