TRY-OUT CAMP

2011 -2012



The Utah Lady Grizzlies are pleased to announce their Try-Out Camp for the 2011 -2012 season. The Try-Out Camp is being held on September 10th and 11th at the Davis County Recreation Center from 3:15 pm to 4:45 pm. Players must attend one of the ice sessions and are encouraged to attend both sessions. Players who want to play for the Lady Grizzlies and cannot make one of these ice sessions must contact Gil Newton, Head Coach (gdnewton13@msn.com), to make special arrangements or be granted an exception. A Try-Out Camp Fee of \$30 is due upon checking in to the Camp. Players must also bring a copy of their 2011 – 2012 USA Hockey Registration to the Camp. Players cannot be allowed on the ice without the USA Hockey Registration form.

A parent meeting will be held on September 10th during the on-ice session to introduce the program for the 2011 – 2012 season.

The Utah Lady Grizzlies is a competition team of girls and young women ages 14 through 18. The team typically plays 10 to 15 local scrimmage games, travels the intermountain west to 3 or 4 tournaments and hosts a Martin Luther King Holiday Tournament in Ogden.

Experienced girl hockey players under the age of 14 may be allowed to try-out for the Lady Grizzlies only upon advance approval by the Head Coach, or if they have previously been rostered on a Lady Grizzly Team. Girls age 14 and under are encouraged to contact the Salt Lake County Lady Lightning. Girls on the Lady Grizzlies team age 14 or under may play on both the Lady Grizzlies and the Lady Lightning. New for the 2011—2012 season:

The Lady Grizzlies are exploring a new program for the 2011 – 2012 season. We are currently scheduling for several additional practice sessions per month to 1) provide extra practice time for those girls who want to participate; and 2) provide an opportunity for girls and young women who play for another hockey team and cannot practice with the team at the regular practice on Sunday afternoons, to also participate on an all girls team.

The cost of the program is still being finalized and will be presented at the first parent meeting. The total cost depends largely on how many girls choose to participate. An approximate summary of the costs assuming 15 participants, are as follows:

- Primary Practices (19), Scrimmage Games (~15), Tournament Fees (4) = \$780/season or \$130/month (there will be a 5% discount for paying the full season fee in advance \$740)
- Alternative Practice (14) = \$175/season or \$30/month

The Utah Lady Grizzlies look forward to a great season and hope you will consider participating in our program this season.
