I, the undersigned, declare that:

1. I agree to abide by the IIHF Statutes, By-laws and Regulations, including those related to players transferring from one country and/or national association to another country and/or national association.
2. I agree not to involve any third party whatsoever outside the IIHF in the resolution of any dispute arising from my request to transfer from one country to another and/or the Statutes By-laws and Regulations and decisions made by the IIHF relating thereto excepting where having exhausted the appeal procedures

- within the IIHF in which case I undertake to submit any such dispute to the jurisdiction of the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland for definitive and final resolution.
3. I am aware that transferring to another country may affect my eligibility to play for the national team of my choice if applicable.
4. I understand that once this application has been completed and signed by the parties specified and then by the IIHF, the procedure will be complete and the transfer legal and binding.

The above IIHF Transfer Card (ITC) is to be used for non-US Citizens, (excluding Canadians), to transfer to a USA Hockey member junior program. The cost to process an ITC or incoming import player is \$900 USD. All players, regardless of age, transferring to a junior program require an ITC.

DIRECTIONS: When completing the form, print clearly and do not abbreviate club or association name.

1. Complete the following blanks on the ITC; Name, Player's Signature, Place of Birth, Date of Birth, Citizenship, Last Club, New Club. The lines for old national association and new national association should be left blank.
2. Submit the form via fax or email to USAH for processing – 719.538.1160 or barbarab@usahockey.org
3. After form is submitted to USAH, claim the player through your Cyber Sport program. USAH will process the ITC with the outgoing federation.
4. Once approved ITC is received at USAH from outgoing federation, incoming team will be notified to process player add to protected list.
5. Original ITC will be sent overnight to incoming team to process the original ITC in the same manner. USAH will enclose a return envelope and ITC should be returned within 5 days of receipt. After original ITC is returned to USAH, your team has completed the ITC process.

TIMELINE: An international player will not be added to a protected list until the approval from outgoing federation is received on the ITC card. This process will take a minimum of 48 hours, provided the player is not under a contract in home federation. After receiving the fax/email approval, the original card must be completed with USAH and the IIHF within 30 days.
