## Release and Waiver Agreement

The player's parent or guardian, as applicable, agrees on behalf of the player to the following:

The player acknowledges that fast pitch softball is a strenuous physical and mental activity and that accidents and physical injuries, including serious bodily injury, permanent disability, paralysis and death, are risks to the player from the activity. The player represents that she is in good health and in proper physical condition to participate in the softball activities conducted, held or sponsored by the SGSA.

The player acknowledges that she is responsible for providing her own medical insurance and is responsible for any and all medical expenses player may incur in participating in the softball activities conducted, held or sponsored by the SGSA. The player consents to the SGSA coaches, instructors and other volunteers providing temporary first aid to the player in the event of injury or illness and, if deemed necessary, treatment by a doctor or other medical professional, and to the transport to a medical facility.

The player expressly agrees to assume the hazard and risk of any and all accidents or injuries, including those identified above, incident to the activities of the player while participating in any softball activity conducted, held or sponsored by the SGSA. The player releases, discharges and covenants not to sue the SGSA, its instructors, coaches and other volunteers of any of the foregoing, the other participants in the activities and any owners of property where the activities are held (the "Releasees"), from any and all liability, claims, demands, losses, damages and expenses, including attorney fees, alleged to be caused in whole or in part, directly or indirectly, by any of the Releasees, in connection with any activities.

The player agrees to defend, indemnify and hold harmless the Releasees, and each of them, from any claims, injuries, liability or damage, including attorneys fees, directly or indirectly sustained, claimed or resulting from or during any activities, including any softball activity conducted, held or sponsored by the SGSA.

The player waives any and all rights to compensation in any form, for pictures, films or videotapes taken of the player in any activity conducted, held or sponsored by the SGSA and consents to them being used for any publicity or publication purposes. The player acknowledges that she may not assign any of her rights, duties or obligations under this Agreement.

By signing below, the player's parent or legal guardian acknowledges the risks of the activities contemplated hereby and agrees to the terms above for themselves and on behalf of the player.
