1. Permission & Release: I, the undersigned parent/legal guardian of _____ ("Camper") authorize Camper's participation in the Dallas Deuces Lacrosse Organization, Inc. Summer Camp and all related games and activities ("Camp"). In and for consideration of Player's participation in the Camp, I hereby release and forever discharge and agree to indemnify and hold harmless Dallas Deuces Lacrosse Organization, Inc., Deuces Camps, LLC, Jesuit College Preparatory School, their employees, officers, directors, shareholders, representatives, subsidiaries, affiliates, partners, operators and any and all other individuals and entities associated therewith from any and all claims, suits, liability for damages, economic or otherwise, sustained by reason of any personal injury or death, arising out of, or directly or indirectly occasioned by (i) Player's participation in the Camp, and /or (ii) Camper's activities upon the premises where the Camp is conducted. In addition, I fully understand the inherent dangers of participating in the sport of lacrosse, including, without limitation, the risks of catastrophic injury, paralysis and even death.
2. Medical Permission: I represent and warrant that Camper has been examined by a physician and found to be in good health and able to compete in all Camp activities without restrictions. Furthermore, I give my consent and permission to the employees of Dallas Deuces Lacrosse Organization, Inc., Deuces Camps, LLC and/or the employees of the Camp, to provide, through a medical staff of their choice, any and all medical, transportation and emergency services as warranted to Camper as a result of Camper's participation in the Camp and I agree to be responsible for any and all costs related thereto.
3. Photo Release: As the parent or legal guardian of Camper, I hereby verify by my signature below, that the Camp has permission to use my son's photographs in materials and brochures promoting the Camp.
4. Refund Policy: A \$35 administrative fee ("Administrative Fee") will be retained if you cancel, regardless of the reason. After May 15, 2009, refunds less the Administrative Fee will only be made for medical reasons and such refund requests must be accompanied by a letter from a physician detailing the medical reason(s) why the Camper cannot participate in the Camp. There will be no refunds for injuries that occur during Camp. If a Camper is dismissed or voluntarily withdraws from Camp, there will be no refunds. If an event occurs where you cannot come to Camp and you have already registered, we encourage you to try and find another Camper to take your spot and have that Camper reimburse you directly for any amounts you have expended on the Camp. Please notify us if you accomplish this so that we can get the new Camper to execute this Liability Waiver and the Camp registration form.
