Mark your calendars!!! Traveling evaluations are the weekend of March 23, 2012. Times are TBD and will be posted on the website as we get closer to the date. Please note, a \$20 tryout fee will apply at the time of evaluations, to assist in defraying the cost of evaluators and facility charges. Players must participate in all scheduled tryout session(s), unless an excused absence is granted by STMA GFA. An excused absence from any of the scheduled sessions **MUST** be granted prior to the start of the session(s), whenever prior notification is possible. Excused absences will include illness or injury (doctors note is required for illness and injury), required school functions, family vacations, and games for in-season sports. Players who are absent from all tryouts without being excused will not be eligible for the top teams. Players who miss the scheduled tryout sessions due to an excused absence, may be granted an alternate tryout session (if available) or will be placed on a team based on other available information from prior periods and at the discretion of the board.
