1.0 Policy Updates

1.1 Binding Commitment – Parent/Guardian Acceptance

As one of the conditions of a binding commitment – GEVA requires parent(s) and/or guardian(s) to acknowledge and provide a signature of acceptance of the GEVA Recruiting and Commitment Policy as provided in the section 3 of the GEVA Juniors Parent Information Guide for the 2016-2017 season. Binding commitment requirements are further defined in this document under section 3.4.

It is recommended that clubs obtain one signature as part of their offer acceptance process that covers the commitment to the club as well as the acceptance of the GEVA policies for the season. Here is a recommended format that can be used for Parental / Guardian acceptance signature (Note: a document such as this must be retained for the season and will be required at the conclusion of the 2016-2017 season to place any player(s) on regional hold).

2.0 Clarifications of Policies

2.1 Playing for More Than One Team in a Club

There are many times during the club season that a player from one team will participate in an event with another team. The player must be put on the webpoint roster with the second team.

Restriction: Players can not participate with two different teams for the same event. This means GEVA Regionals, GEVA Open Power Series and other events such as NEQ or other out of region events that occur on multiple weekends.

Clubs/Teams that violate this policy will be penalized in accordance with USAV policies and GEVA ByLaws.
