The 2009 CLSF Annual Meeting and Mandatory Winter Rec League Coaches Meeting will be held on Tuesday, February 24, 2009, at 7:00 P.M. The meeting will be held at the Coventry Elementary School (mutipurpose room) located at 820 Darlington Lane, Crystal Lake, IL. The school is located in the Coventry Subdivision.

This year the mandatory Rec Coaches Meeting will be positioned first on the agenda. We anticipate that the Coaches Meeting will take about ½ hour. The Annual Meeting will then be called to order immediately following the conclusion of the coaches meeting.

The purpose of the coaches' portion of the evening is to provide information for the upcoming Spring Season. The head coach, an assistant coach, or other team representative is required to attend this
