



**General Information:**

You must submit a separate Team Entry for each Team Event that you enter for the 2018 USA Fencing National Championships (do not list more than one team on this form). Entry form must be complete with team member names and membership numbers in order to be processed. Any changes to team member names must be received by May 30, 2018 (team captains can adjust the roster during their check in at the venue).

All Paper Entries have a \$20 Administrative Processing Fee. All entries must be received by the posted deadlines no later than 11:59:59 PM Pacific Time. No paper entries will be accepted after May 16, 2018. No entries will be taken at the door. Classifications are no longer awarded in team championship events [BoD March 2012].

Teams may register [online only](#) during the triple fee period May 16-30, 2018; the total amount due per Team Entry submitted during this period is \$390.00.

**Team members competing ONLY in the Team competition must submit an Individual Entry Form or register [online](#) with payment of the \$65 registration fee and \$5.00 admin fee by the regular fee deadline.**

**Senior/Veteran Team:** these are an open team events and you will have to meet the age criteria to enter. Team members must be current competitive USA Fencing members or foreign athletes with an FIE License or current Federation membership. No more than 3 teams per USA Fencing member club per event will be allowed to enter.
