Can book for the entire season but only 1 practice/week.

Book practice time on the hour only.

Practice length is one hour or less.

Fields that can be booked for practice:

North West Soccer (Burton Field) runs n/s

South East Soccer (Burton Field) runs n/s

Middle Soccer (Burton Field) runs e/w

Reynolds

Peasley North Soccer

Peasley South Soccer

After 7p only 1 field for older teams at Peasley

Practices will not be scheduled on Men's Club Field as per SOCS game field requirements.

Household Information Form must be on file before any reservation can be made. Proof of residency required when submitting HHIF at the front desk – residents and non-residents.

In-person reservations will not be taken.

A field permit will be emailed to you once it is confirmed.

If the day/time you request is not available, you will be notified.

Use of nets is first come, first serve at Burton and Peasley Park.

Huntington Woods Parks & Recreation Scheduling Soccer or Baseball Fields for Practice

Field use is by permit only. To schedule a practice for HWP&R, SOCS or Dads Clubs (minor/coach pitch and major/kid pitch ONLY) coaches can email the Recreation Department for field availability at cnutton@hwmi.org. An updated Household Information Form must be on file with the Recreation Department to schedule. Forms may be found at the front desk of the HW Recreation Center. Proof of residency must be confirmed when turning form in. After emailing your field requests, our Records Manager will email you a field permit.

Priority of Use - Huntington Woods Parks and Recreation Department functions/games/practices take priority on the fields. When scheduling, the department will give priority to SOCS and Dad's Club games over practices (including rescheduling rainouts).

Timetable for Use (updated Household Information Forms must be on file for all coaches prior to requesting fields)
BERKLEY DAD'S CLUB – once a schedule is drawn and coaches names/addresses are on file with the Rec Department.
SOCS – coaches may begin requesting practices after the coaches meeting, when all coaches names/addresses are on file with the Rec Department.

The fields are as follows (soccer practices are one hour in length maximum);

- 1. Burton I Baseball Diamond behind the HWP&R. Burton Fields are NOT available for Dad's Club practices.
- 2. Burton 2 Baseball Diamond next to Nadine. Burton Fields are NOT available for Dad's Club practices.
- North West Soccer The right outfield of Burton 1 is used as a practice soccer field and is registered under NW SOCCER. No soccer practices may be scheduled during baseball games.
- **4. South East Soccer** The right outfield of Burton 2 is used as a practice soccer field and is registered under SW SOCCER. No soccer practices may be scheduled during baseball games.
- 5. **Middle Soccer** in between the two baseball fields and used for soccer practices only. No soccer practices may be scheduled during baseball games.
- **Peasley Park** (on Balfour/Coolidge). This is an open green space and is available for soccer (not baseball) practice. Please note that parking is very limited. Practices are one hour in length maximum. Before 7:00 pm, up to 2 practices can be scheduled. There is a set of goals on this field.
- 7. Reynold's Park (next to Sam's Market). This is an open green space and is available for soccer (not baseball) practice. Practices are one hour in length.
- 8. Men's Club On Eleven Mile, next to the church. This field is reserved for baseball use during the week and SOCS games are scheduled throughout the weekend. No soccer practices may be scheduled at this field. There is **NO USE** of the Men's Club Field on Thursday, as the church has services (Mid May end of August). Baseball practices are 1.5 hours in length maximum.


Here are some additional rules for Men's Club Field, in an effort to keep the field in optimal condition for everyone's enjoyment:

- I. Field use is by permit only.
- 2. No ball playing during soccer games.
- 3. No ball playing when church is in session.
- 4. No ball playing/soccer in church parking lot.
- 5. The field is available for minor and major league baseball use ONLY.
- 6. After playing, please fill in holes/divots in the infield and batter's box and rake the field.
- 7. The distance between the mound and home plate is ~50", the bases are set at 60'.
- 8. Go green! Please pick up all trash from the field/dugouts when you leave.

Good sportsmanship by coaches and players is imperative at all times. HWP&R reserves the right to terminate booking privileges' should poor sportsmanship become a problem.

Baseball teams and soccer teams schedule in the same manner and are subject to the same rules. Please attempt to accommodate each other as much as possible during your practices. Soccer teams are **not** eligible to schedule practices when baseball games are being played at Burton (and no practices at Men's Club Field ever).
