

## Privacy Policy

This Privacy Policy governs the manner in which MV Ventures Management, LLC (hereinafter referred to as "MV Ventures") and any affiliated entity that may reference or link to this Privacy Policy collects, uses, maintains and discloses information from users (each a "User") in any form. This Privacy Policy applies to all products and services offered by MV Ventures.

### **Personal identification information**

MV Ventures may collect personal identification information from Users in a variety of ways, including, but not limited to, when Users visit an MV Ventures website, fill out a form (electronic or otherwise), provide information via a social platform, or as otherwise provided to or collected by MV Ventures in connection with other activities, services, features or resources MV Ventures may make available. ### **Non-personal identification information**

### **Web browser cookies**
