



VEGAS GOLDEN KNIGHTS PRIVACY POLICY

This Privacy Policy, effective January 1, 2019, explains how Black Knight Sports and Entertainment LLC, dba Vegas Golden Knights and its affiliates (collectively, the "Vegas Golden Knights," "we," "our," "us"), use information obtained in operating our websites, mobile apps, other online services or by other means (collectively, our "Services"). This Privacy Policy does not apply to the websites, apps, or services of the National Hockey League ("NHL") or any of the other member clubs of the NHL ("Member Clubs"), which are governed by their own privacy policies. By using our Services, you consent to the terms of our Privacy Policy. By submitting information to us, you consent to the collection and use of that information in accordance with this Privacy Policy.

Types of Information We Collect

Information You Provide Directly. We receive information you provide when using our Services, including when you register for our Services; sign up for electronic newsletters, marketing emails or other communications; participate in a survey, contests or sweepstakes; log on to our Guest WiFi; or otherwise communicate with us. The information you provide to us may include first and last name, online username and/or email address, phone number, mailing address, date of birth, user content, personal preferences or payment information.

Information Collected When You Use Our Online or Mobile Services. When you use our Services online, we may collect or receive information using cookies, web beacons, and other technologies. This information may be combined with other information you provide to send you personalized content and ads based on your interests. Depending on how you access and use our Services, we may receive:

- **Log information.** Our servers automatically log and store certain browsing information when you use our Services online, like browsing history, time, date and duration of your visit, browser or operating system data, your Internet Protocol ("IP") address, and the websites you visit before and after accessing our Services.
- **Device information.** We automatically collect and store information concerning the device used to access our Services. Device information may include the device type (e.g., your particular brand of phone or tablet), device identifiers unique to your device, and your Internet service provider.
- **Location information.** When you use location-enabled services on your device, we may receive specific location information drawn from your device's GPS or Bluetooth signal and information about nearby WiFi networks and cell towers.
- **Information from third-party sources.** We may receive additional information about you that is publicly or commercially available, from the NHL, or from our business partners. We may also receive information about you if you connect with social networking services while using our Services.

How We Use Information

To provide you Services. We use your information to provide you with the Services you use or request. We may use your information to create accounts, process transactions, provide technical and user support, send marketing communications about our affiliates and third-party services and other notifications to you, administer your participation in contests or promotions, or to customize your user experiences, among other things.

To improve our Services. We may also use the information to improve our Services, to solicit input and feedback about our Services, identify and address technical issues on our Services, or enhance our ability to detect and prevent fraud or potentially illegal activities and otherwise enforce our Terms of Service.

To market to you. We may use the information to show you ads for our Services and affiliated and third-party services on our websites and to send you promotional communications about us, the NHL, or other business partners. We also may use the information we collect and receive for other purposes that may be described to you at the point of collection or for which you provide your consent.

How We Share Information

We may share information with:

- **Our affiliates.** We may share information with current and future affiliates, our affiliates include our direct and indirect shareholders and subsidiary companies, joint venture partners, or other companies we control, we are controlled by, or with which we are under common control or ownership.
- **Our service providers.** We may provide information about you to service providers that perform services on our behalf. These companies are contractually limited in the ways in which they may use this information.
- **Our business partners.** We may share information about you with business partners that are not our service providers, such as sponsors, broadcast partners, and retail licensees, to market to you for their own purposes. Business partners are expected to protect the information we share with them. We are not responsible for the privacy practices of our business partners and are not liable for any injury, loss or damage arising from or in connection with their use of your information.
- **Other parties** when required or permitted by law. We may disclose your information to other parties when required by law or in the good-faith belief that doing so is necessary to respond to lawful governmental requests or legal process; to protect the rights, property or personal safety of our users, the public or us; and to enforce the terms of this Policy or our Terms of Service.
- **Other parties in connection with certain business transactions.** We reserve the right to transfer your information in connection with the restructure, sale or other disposition of all or part of our business, or, in the event of bankruptcy, reorganization, insolvency, receivership or an assignment for the benefit of creditors.

If you create or log into your NHL.com, NHL.TV or other account while visiting our Services, you may be "signed in" or "logged on" to your account while visiting our Services. As a result, the NHL, its affiliates or account operators may be able to collect certain information about your use of our Services, which they may use in accordance with their privacy policies. Likewise, we may receive certain information from NHL, its affiliates and service providers, which we will use in accordance with this Privacy Policy. The information may include name; username; contact information; type of subscription; type of device used to access content; and time, date and duration of activity.

Your California Privacy Rights

Your online access to some of your information may be protected with a password that you select. Children's Privacy

Our website is not intended for children under 16 years of age. No one under age 16 may provide any information to or on the website. We do not knowingly collect personal data from children under 16. By using our Services or by providing us with your information, you consent to this collection, transfer, storage, and processing of information to, in, and out of the United States.

To the extent our activities are subject to international data protection laws that specify limited legal grounds to process your information, the legal bases for our processing activities are to perform our contract(s) with you; to meet our legal obligations; and for our legitimate business purposes, including to improve our operation and Services, detect and prevent fraud, and enforce our Terms of Service. We rely on your consent to send you direct marketing messages about our products, services and promotions and to deliver targeted advertisements to you, both on and off the Services. We will not keep your personal information for longer than is necessary for the purpose it was collected.

Cookies, Web Beacons, and Other Technologies

Our Services use may include online technologies called "cookies" and "web beacons," as well as other local storage technologies. This section explains what these technologies are and how they may be used.

Cookies and Other Local Storage Technologies

Generally speaking, "cookies" are text files that are placed in your device's browser, and that can be used to help recognize your browser across different web pages, websites, and browsing sessions. Your browser or device may offer settings related to cookies. For example, you may be able to configure your browser not to accept cookies or to notify you when a cookie is being sent. For more information about whether these settings are available, what they do, and how they work, visit your browser or device's help material. If you decide not to accept cookies from us, you may not be able to take advantage of all of the features of the Services.

Cookies are stored on your device or in "local storage." We also use other types of local storage technologies, such as Local Shared Objects (sometimes called "Flash cookies"), in connection with our Services. These technologies are similar to cookies in that they are stored on your device and can be used to maintain information about your activities and preferences.

However, these other local storage technologies may use parts of your device other than your browser, which means you may not be able to control their use using the browser tools and settings you use to control browser cookies. Your browser's privacy controls may enable you to manage other types of local storage.

Our Services may use cookies or other local storage technologies in combination with other information about you to enhance and personalize your experience on our Services (or elsewhere online), including:

- to help authenticate you when you use our Services;
- to remember your preferences and registration information; to enable a shopping cart;
- to present and help measure and research the effectiveness of our Service, advertisements, and email communications (by determining which emails you open and act upon); and

Web Beacons

Web beacons are small pieces of code placed on Web pages, videos, and in emails that can communicate information about your browser and device to a server. Beacons can be used, among other things, to count the users who visit a Web page or read an email, or to deliver a cookie to the browser of a user viewing a Web page or email.
