

PRIVACY POLICY

This Privacy Policy applies to the websites and services operated by the Albany Berkeley Girls Softball League ("ABGSL," "we," "us," or "our"), accessible via abgsl.org and any other online and/or mobile applications or websites operated by us that are related to us or abgsl.org (collectively, the "Services"). We are incorporated in the United States. This Policy (together with our Services Terms and Conditions and any other documents referred to in this policy) sets out how we may or will use any personal information which you provide through Our Services. Please read it carefully before you proceed. By visiting our services, and/or using the services offered on or through our services, you acknowledge you agree to the terms of this Privacy Policy as it may be amended from time to time. This Privacy Policy is incorporated into, and part of, the Terms and Conditions of our services, which governs your use of our services.

1. INFORMATION WE COLLECT

Information you provide us:

- For an individual user when you register for an account, we collect, a minimum, your email address, a password, your name. Depending on how you use the Services, we may also collect
 - Contact information such as address and phone number of players and family members;
 - Team member information, including where applicable information about your children, including, but not limited to health insurance information;
 - Team information, such as rosters, schedules, attendance;
 - Payment information;
 - Messages you send to us; and
 - Transactional information.

2. HOW WE USE THE INFORMATION

We use the information we collect in the following ways:

- Provide the Services, including
 - responding to your requests or inquiries; or providing technical support;
 - sending you service-related communications, including announcements and administrative messages;
 - displaying certain content, such as content you upload and make available, comments, messages, scores, availability; and photos.

- For any specific purpose for which it was provided or volunteered.
- To sending you information about services and promotions offered by Us or our partners.
- To Prevent fraud and defend our legal rights, including to
 - protect the safety of our users and others;
 - enforce our terms of service; and
 - prevent fraud or any other potentially illegal activities.
- To comply with applicable law

3. DISCLOSURE OF INFORMATION

We may share your information:

- With service providers that perform certain business-related functions on our behalf: including analytics, website hosting, transaction fulfillment, or payment,
- As required by law in with Law Enforcement Agencies or Regulators to:
 - protect our legal rights, privacy or safety, and that of our users, or other individuals;
 - protect against fraud or other illegal activity;
 - respond to inquiries or requests from government, law enforcement, or public authorities;
 - comply with the law including with subpoenas, search warrants, court orders, and other legal process; or
 - enforce applicable terms of service.
 - National Governing Bodies: We may share your information with the following National Governing Bod(ies): USA Softball, All Star Tournaments Fastpitch, and Safesport, for instance to confirm your eligibility to participate in a sport.

4. SPORTSENGINE

The Services are powered by SportsEngine. SportsEngine collects information from users depending on how they use the Services, as set forth in the NBCUniversal Privacy Policy.

- For logged in users, SportsEngine may collect:
 - device identifiers and usage data for analytics purposes,
 - data related to messages in the SportsEngine account, and
 - volunteer information such as name and email address.

- When administrators are logged in, SportsEngine may collect:
 - device identifiers and usage data for analytics purposes,
 - data related to messages in the SportsEngine account,
 - administrator information such as name and email address data, and other relevant information when the administrator connects with SportsEngine personnel, for instance through the built-in chat feature.
- When users are not logged in to SportsEngine, SportsEngine collects device identifiers and usage data for analytics purposes.

5. HOW WE PROTECT YOUR INFORMATION

We maintain procedural, technical, and physical safeguards to help protect against loss, misuse or unauthorized access, disclosure, alteration, or destruction of the information you provide. These safeguards vary depending upon the sensitivity of the information we collect and store. Please be aware that no security solutions are infallible.

6. RETENTION

Your information will be retained for as long as is reasonably necessary for the purposes listed above or as required by applicable local law. We may keep an anonymized form of your personal information, which will no longer refer to you, for statistical purposes without time limits, to the extent that we have a legitimate and lawful interest in doing so.

7. YOUR RIGHTS & CHOICES

- You may unsubscribe from our email newsletters or promotional emails by following the opt-out instructions contained in the email. You cannot unsubscribe from service-related, transactional, or emails.
- You use you may be able to access and correct certain information through the features provided by the Services. In addition, where legally required, we will provide users with access to their information and the ability to review, update, correct, and/or delete it. We will take reasonable steps to verify your identity.

8. PUBLIC AND INTERACTIVE AREAS OF OUR SERVICES

Personal information that you post on or through the public areas of our Services are generally accessible to, and may be collected and used by, others and may result in unsolicited messages or other contact from others. You should not provide personal information about yourself in public or interactive areas of Our Services. Such personal information is not covered under this Privacy and Cookie Policy.
